

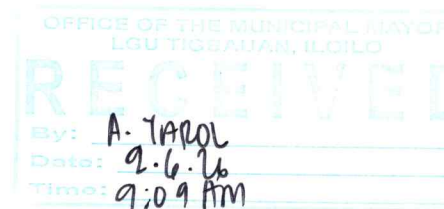

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANETTE LORETO-GARIN THROUGH THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC), REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE CONSTRUCTION OF MULTI-PURPOSE BUILDING INCLUDING FACILITIES (TIGBAUAN ARENA) AT TIGBAUAN, ILOILO IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00).

WHEREAS, the Municipality of Tigbauan, Province of Iloilo, recognizes the vital role of modern, safe, and inclusive public infrastructure in promoting social development, sports excellence, cultural activities, and community engagement;

WHEREAS, the Municipality currently lacks a large-scale, permanent multi-purpose facility capable of accommodating major sports competitions, cultural events, public assemblies, and other large community and government-initiated activities;

WHEREAS, the proposed construction of a Multi-Purpose Building including facilities, to be known as the Tigbauan Arena, will serve as a central venue for sports development, youth and cultural programs, conventions, trainings, and other socio-civic activities in the Municipality;

WHEREAS, the proposed project with an estimated construction cost of Fifty Million Pesos (P50,000,000.00) is aligned with the local, provincial, and regional development frameworks and is consistent with national government priorities on resilient infrastructure, sports development, youth empowerment, and inclusive growth;

WHEREAS, there is a need to request financial assistance from the Office of Congresswoman Janette Loreto-Garin through the Department of Public Works and Highways (DPWH) to ensure the implementation of the said project;

WHEREAS, the endorsement and approval of the Provincial Development Council (PDC) and the Regional Development Council (RDC) are necessary for the inclusion, funding, and timely realization of the Tigbauan Arena project.

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to request Financial Assistance from the Office of Congresswoman Janette Loreto-Garin Through the Office of the Department of Public Works and Highways (DPWH) and Requesting the Provincial Development Council (PDC), Regional Development Council (RDC) to Approve Construction of Multi-Purpose Building Including Facilities (Tigbauan Arena) at Tigbauan, Iloilo in the Amount of Fifty Million Pesos (P50,000,000.00);
