

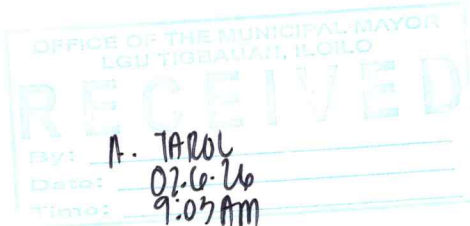

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANETTE LORETO GARIN THROUGH THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC), REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE CONSTRUCTION OF MULTI-PURPOSE BUILDING INCLUDING FACILITIES AT SITIO LINO FLORES, BARANGAY BAGUINGIN, TIGBAUAN, ILOILO IN THE AMOUNT OF EIGHT MILLION PESOS (P8,000,000.00).

WHEREAS, Barangay Sitio Lino Flores, Municipality of Tigbauan, Province of Iloilo, has no permanent multi-purpose facility for barangay assemblies, community gatherings, sports, youth development activities, livelihood trainings, and other government programs;

WHEREAS, the proposed construction of a Multi-Purpose Building including facilities will provide a safe and functional venue for community activities and may also serve as an evacuation center during emergencies and calamities;

WHEREAS, the project will promote community development, social cohesion, and inclusive participation of various sectors, particularly the youth, senior citizens, and other vulnerable groups;

WHEREAS, the proposed project aligns with municipal, provincial, and regional development priorities and national policies on disaster risk reduction, community development, and resilient infrastructure;

WHEREAS, pursuant to Section 17 of Republic Act No. 7160 (Local Government Code of 1991), which mandates local government units to provide basic services and facilities for the general welfare of constituents, and considering the limited financial capacity of the Municipality, there is a need to request financial assistance in the amount of Eight Million Pesos (P8,000,000.00) from the Office of Congresswoman Janette Loreto-Garin through the Department of Public Works and Highways (DPWH), and to seek the endorsement and approval of the Provincial Development Council (PDC) and Regional Development Council (RDC).

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to request Financial Assistance from the Office of Congresswoman Janette Loreto-Garin Through the Office of the Department of Public Works and Highways (DPWH) and Requesting the Provincial Development Council (PDC), Regional Development Council (RDC) to Approve Construction of Multi-Purpose Building Including Facilities at Sitio Lino Flores, Barangay Baguingin, Tigbauan, Iloilo in the Amount of Eight Million Pesos (P8,000,000.00);
