

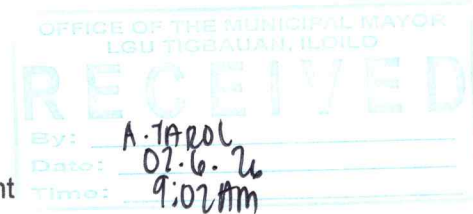

 RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANETTE LORETO-GARIN THROUGH THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC), REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE CONSTRUCTION OF MULTI-PURPOSE BUILDING INCLUDING FACILITIES AT BARROC ELEMENTARY SCHOOL, BARANGAY BARROC, TIGBAUAN, ILOILO IN THE AMOUNT OF EIGHT MILLION PESOS (P8,000,000.00).

WHEREAS, the Municipality of Tigbauan, Province of Iloilo, continues to prioritize the development of educational and community-support facilities that promote public welfare, safety, and inclusive growth;

WHEREAS, the proposed construction of a Multi-Purpose Building including facilities within the premises of Barroc Elementary School will provide a safe and functional venue for educational, cultural, and social activities, benefiting both the pupils and the residents of Barangay Barroc;

WHEREAS, the said facility may also be used as an evacuation center during emergencies and calamities, thereby enhancing disaster preparedness and response capabilities of the school and the surrounding community;

WHEREAS, the proposed project is aligned with the local, provincial, and regional development goals, as well as national government priorities on education support, community development, and resilient public infrastructure;

WHEREAS, the Municipality has limited financial capacity to fully fund the construction of the said facility, thus necessitating the request for financial assistance in the amount of Eight Million Pesos (P8,000,000.00) from the Office of Congresswoman Janet Loreto-Garin through the Department of Public Works and Highways (DPWH);

WHEREAS, the approval and endorsement of the Provincial Development Council (PDC) and the Regional Development Council (RDC) are required to ensure proper funding, inclusion, and timely implementation of the proposed Multi-Purpose Building project;

Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to request Financial Assistance from the Office of Congresswoman Janette Loreto-Garin Through the Office of the Department of Public Works and Highways (DPWH) and Requesting the Provincial Development Council (PDC), Regional Development Council (RDC) to Approve Construction of Multi-Purpose Building Including Facilities at Barroc Elementary School, Barangay Barroc, Tigbauan, Iloilo in the Amount of Eight Million Pesos (P8,000,000.00);
