

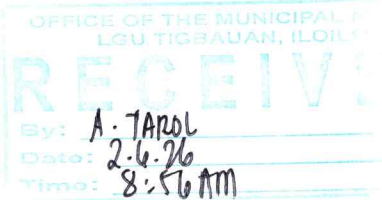

RESOLUTION REQUESTING FOR ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANETTE LORETO-GARIN, THRU THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC) AND REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE THE CONCRETING OF SIPITAN AND SITIO KARAYA ROAD (CORDOVA NORTE), TIGBAUAN, ILOILO IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00)

WHEREAS, Sitio Sipitan and Sitio Karaya Road located in Barangay Cordova Norte, Municipality of Tigbauan, Province of Iloilo serves as an important access road for residents, farmers, students, and motorists in the area;

WHEREAS, the said road remains unpaved and is in poor condition, especially during the rainy season, causing difficulty in transportation, delays in delivery of basic services, and safety risks to the public;

WHEREAS, the concreting of Sipitan and Sitio Karaya Road will significantly improve mobility, promote economic activities, ensure public safety, and enhance access to social services within the barangay and neighboring communities;

WHEREAS, the estimated cost for the concreting of Sipitan and Sitio Karaya Road amounts to Twenty Million Pesos (P20,000,000.00), which is beyond the financial capacity of the Barangay and Municipal Government;

WHEREAS, the Office of Congresswoman Janette Loreto-Garin, thru the Department of Public Works and Highways (DPWH), has been instrumental in providing infrastructure assistance to local government units in the Province of Iloilo;

WHEREAS, approval and endorsement of the Provincial Development Council (PDC) and the Regional Development Council (RDC) are necessary to facilitate the implementation of the said infrastructure project;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,

RESOLVED, to request for assistance from the Office of Congresswoman Janette Loreto-Garin, thru the Office of the Department of Public Works and Highways (DPWH) and requesting the Provincial Development Council (PDC) and Regional Development Council (RDC) to approve the concreting of Sipitan and Sitio Karaya Road (Cordova Norte), Tigbauan, Iloilo in the amount of Twenty Million Pesos (P20,000,000.00)

RESOLVED, FURTHER, to request the Provincial Development Council (PDC) and the Regional Development Council (RDC) to give favorable consideration and approval to the said project for inclusion in the appropriate development and investment programs;

RESOLVED, FINALLY, that copies of this Resolution be furnished to the Office of Congresswoman Janette Loreto-Garin, the Department of Public Works and Highways (DPWH), the Provincial Development Council (PDC), the Regional Development Council (RDC), and other concerned offices for their information and appropriate action.
