

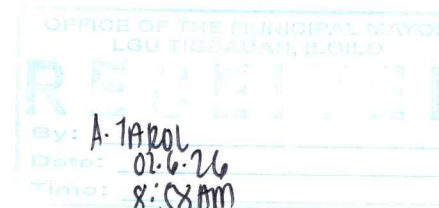

 RESOLUTION REQUESTING FOR ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANETTE LORETO-GARIN, THRU THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC) AND REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE THE CONSTRUCTION FOR THE IMPROVEMENT OF HANGING BRIDGE (BAYUCO-DORONG-AN), TIGBAUAN, ILOILO IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00)

WHEREAS, the Hanging Bridge connecting Bayuco and Dorong-an in the Municipality of Tigbauan, Province of Iloilo, serves as a vital passage way for residents, farmers, students, and commuters in accessing basic services, livelihood, and neighboring communities;

WHEREAS, the existing condition of the said hanging bridge has deteriorated due to wear and exposure to the elements, posing safety risks to pedestrians and hindering the efficient movement of people and goods;

WHEREAS, the construction and improvement of the Hanging Bridge (Bayuco-Dorong-an) will ensure public safety, improve connectivity, and contribute to the social and economic development of the affected barangays;

WHEREAS, the estimated cost for the construction and improvement of the Hanging Bridge amounts to Five Million Pesos (P5,000,000.00), which is beyond the financial capacity of the Municipal Government;

WHEREAS, the Office of Congresswoman Janette Loreto-Garin, thru the Department of Public Works and Highways (DPWH), has continuously extended support to infrastructure projects that improve accessibility and public safety in the Province of Iloilo;

WHEREAS, approval and endorsement by the Provincial Development Council (PDC) and the Regional Development Council (RDC) are required for the implementation and funding of the proposed project;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,

RESOLVED, to request for assistance from the Office of Congresswoman Janette Loreto-Garin, thru the Office of the Department of Public Works and Highways (DPHW) and requesting the Provincial Development Council (PDC) and Regional Development Council (RDC) to approve the Construction for the Improvement of Hanging Bridge (Bayuco-Dorong-an), Tigbauan, Iloilo in the amount of Five Million Pesos (P5,000,000.00)
