RESOLUTION CONFORMING AND APPROVING THE CY 2026 ANNUAL BUDGETS OF BARANGAYS BANTUD, CORDOVA NORTE AND PARARA NORTE, ALL OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on February 10, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2026 Annual Budgets of Barangays Bantud, Cordova Norte and Parara Norte, as duly approved by their respective Sangguniang Barangays, for review and appropriate legislative action;

WHEREAS, the Annual Budget of Barangay Bantud, as approved under Appropriation Ordinance No. 2026-01 dated January 17, 2026, amounts to Three Million Ninety Five Thousand Pesos (P3,095,000.00), with the following budget components: 20% Development Fund (P612,951.80), 10% Sangguniang Kabataan Fund (P309,500.00), 5% Barangay Disaster Risk Reduction and Management Fund (P154,750.00) and Gender and Development (GAD) Attribution (P549,000.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay Cordova Norte, as approved under Appropriation Ordinance No. 2026-01 dated January 25, 2026, amounts to Four Million Seven Hundred Thirty Thousand Pesos (P4,730,000.00), with the following budget components: 20% Development Fund (P925,241.60), 10% Sangguniang Kabataan Fund (P473,000.00), 5% Barangay Disaster Risk Reduction and Management Fund (P236,500.00) and Gender and Development (GAD) Attribution (P852,819.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay Parara Norte, as approved under Appropriation Ordinance No. 2026-01 dated January 15, 2026, amounts to Five Million Seven Hundred Forty Five Thousand Pesos (P5,745,000.00), with the following budget components: 20% Development Fund (P1,117,033.80), 10% Sangguniang Kabataan Fund (P574,500.00), 5% Barangay Disaster Risk Reduction and Management Fund

(P287,250.00) and Gender and Development (GAD) Attribution (P1,110,928.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Municipal Budget Officer, after review, found the said barangay budgets to be compliant with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the responsibility of the concerned barangay officials to ensure the lawful and proper implementation of the approved budgets in accordance with applicable laws and regulations;

NOW THEREFORE, on motion of HON. NORA ROSE T. TUBIANO, Chairperson, Committee on Appropriations, Budget, Finance and Accounts and Ways and Means, duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Juliana Marie T. Julaton,
