 A RESOLUTION TEMPORARILY AMENDING RULE VII, SECTION 14(a) OF RESOLUTION NO. 2025-087, OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE (IRP) OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, BY TRANSFERRING THE REGULAR SESSIONS SCHEDULED ON MARCH 4, 2026 AND MARCH 11, 2026 TO MARCH 2, 2026 AND MARCH 9, 2026, RESPECTIVELY, AT 9:00 O'CLOCK IN THE MORNING

 WHEREAS, Rule VII, Section 14(a) of the Internal Rules of Procedure provides:

"RULE VII – REGULAR AND SPECIAL SESSIONS
Section 14. REGULAR SESSION

- (a) The regular session shall be held every Wednesday and shall start promptly at 9:00 o'clock in the morning; provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause, the next working day shall be the regular session day;"

WHEREAS, the Members of the Sangguniang Bayan are scheduled to attend the Continuing Local Legislative Education Program (CLLEP) of the Philippine Councilors League (PCL) for CY 2025–2027 at the World Trade Center, Pasay City on March 4–6, 2026;
