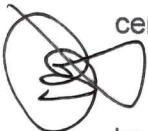

 A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. VIRGILIO TERUEL, TO ENTER INTO NEGOTIATIONS WITH JESUS ASCENSION CEMETERY FOR THE ACQUISITION OF MORE OR LESS ONE THOUSAND (1,000) SQUARE METERS OF LOT NO. 11655, PSC-49, SITUATED IN BARANGAY BUENAVISTA, THIS MUNICIPALITY, FOR THE ESTABLISHMENT OF THE TIGBAUAN MUNICIPAL CEMETERY

 WHEREAS, the Municipality of Tigbauan recognizes the need for a new municipal cemetery to serve the community effectively;

WHEREAS, a suitable parcel of land, specifically a portion of Lot No. 11655, PSC-49, known as Jesus Ascension Cemetery, has been identified for the proposed site;

WHEREAS, the acquisition of this property, consisting of approximately one thousand (1,000) square meters, will fulfill the requirements for establishing a new municipal cemetery in Barangay Buenavista;

WHEREAS, it is necessary to authorize the Municipal Mayor to enter into negotiations with Jesus Ascension Cemetery for the acquisition of lot for the establishment of the Tigbauan Municipal Cemetery;

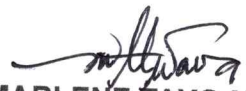
