 RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL LOCAL GOVERNMENT UNIT OF ILOILO AS RECIPIENT/BENEFICIARY OF ONE (1) UNIT CULTIVATOR IN CONNECTION WITH THE IMPLEMENTATION OF THE AGRICULTURE AND FISHERIES MODERNIZATION ACT (AFMA).

 WHEREAS, in a letter dated March 5, 2026, the Hon. Mayor, Atty. Virgilio T. Teruel, requested this August Body for the urgent passing of a “Resolution Authorizing Atty. Virgilio T. Teruel, Municipal Mayor, to Enter Into A Memorandum of Agreement With the Provincial Local Government Unit of Iloilo as Recipient/Beneficiary of One (1) Unit Cultivator in Connection With the Implementation of the Agriculture and Fisheries Modernization Act (AFMA);”

WHEREAS, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The PROVINCIAL LOCAL GOVERNMENT UNIT OF ILOILO, local government created by law with the postal address at the Iloilo Provincial Capitol, Bonifacio Drive, Iloilo City, represented by its Governor HON. ARTHUR R. DEFENSOR, JR., Governor, Province of Iloilo (Sangguniang Panlalawigan Appropriation Ordinance No. 2024-03), referred to as (PLGU-ILOILO); and
- The MUNICIPALITY OF TIGBAUAN is a local government unit with principal address at MUNICIPAL HALL of Tigbauan, Iloilo represented by its Municipal Mayor, HON. VIRGILIO T. TERUEL in his capacity as the Municipal Mayor, by virtue of the Sangguniang Bayan Resolution No. 2026-94, referred to as (RECIPIENT/ BENEFICIARY);

WHEREAS, Republic Act No. 8435, otherwise known as the **Agriculture and Fisheries Modernization Act (AFMA)**, envisions the strengthening of the agriculture and fisheries sector through modernization in order to attain food security, alleviate poverty, enhance income and profitability of farmers and fisherfolk, and promote global competitiveness and sustainability;

WHEREAS, the **Provincial Government of Iloilo (PLGU-Iloilo)**, pursuant to its mandated functions of promoting agricultural development through a bottom-up and self-reliant farm systems approach that emphasizes social justice, equity, productivity, and sustainability in the utilization of agricultural resources, provides integrated services aimed at increasing farm productivity and improving the real income of small farmers;

WHEREAS, the PLGU-Iloilo supports and undertakes programs and activities that assist in and promote the development of agricultural and fisheries machinery industries in the countryside;

WHEREAS, the PLGU-Iloilo is the primary agency in the Province of Iloilo with the administrative and technical capability to effectively implement the said program;

WHEREAS, the **Municipality of Tigbauan** is among the municipalities in the Province of Iloilo with productive agricultural lands that significantly contribute to the province's agricultural economy and is therefore qualified to receive **one (1) unit cultivator**, subject to the terms and conditions of this agreement;

WHEREAS, the **Municipality of Tigbauan** is willing to collaborate in the implementation of the program as recipient-beneficiary;

WHEREAS, the **one (1) unit cultivator**, intended for the Municipality of Tigbauan with a total project cost of **Two Hundred Twenty-Three Thousand Five Hundred Pesos (Php223,500.00)**, is envisioned to enhance agricultural productivity, accelerate rural development, and improve the economic condition of farmers;

WHEREAS, the PLGU-Iloilo, through **Sangguniang Panlalawigan Appropriation Ordinance No. 2024-03, Section 4**, authorizes the Provincial Governor to transfer funds, sign and enter into Memorandum of Agreement, and transfer assets without cost to national agencies, provinces, cities, municipalities, and barangays for the implementation of infrastructure projects, subsidies to local government units, and donations pursuant to Section 381 of the Local Government Code of 1991;

WHEREAS, this undertaking is in compliance with the requirements of the Commission on Audit under COA Circular No. 2012-001 dated June 14, 2012, prescribing the Revised Guidelines and Documentary Requirements for Common Government Transactions.

WHEREAS, for and in consideration of the foregoing premises and considerations, the parties hereto agreed to jointly undertake the Program with the following considerations:

A. The PLGU-ILOILO shall:

1. Regularly monitor the activities of the recipient/beneficiary including the operation and maintenance;
2. Monitor the installation/trial run/testing and evaluation of the facility;
3. Provide such other support or assistance as maybe required by the composite teams to ensure the successful implementation of the project;
4. Reserve the right to intervene, institute corrective measures and repossess the facilities when not fully utilized, or properly used and in case of non-compliance of the parties with the stipulations of this agreement;
5. In coordination with other implementing agencies, turn-over to the recipient/beneficiary the agricultural machinery and issue the Deed of Donation to the recipient/beneficiary.

B. The RECIPIENT/BENEFICIARY:

1. Responsible in shouldering the operating and maintenance cost of the facility;
2. Acknowledge receipt of agricultural machinery;
3. Responsible in coming up with the guidelines and policy of operation, operating scheme, cost and strategies that is appropriate to them with the guidance of PLGU;
4. Utilize the agricultural machinery to its intended use, allow access and use by farmers folk and shall not in any way sell or mortgage the same;
5. Maintain a complete/detailed logbook of the agricultural machinery operation and whenever requested, Agencies/line bureaus/PLGU-ILOILO monitoring team access to the same;
6. Responsible and accountable for the security of the mechanization facility while in their custody and must ensure optimum utilization of the facility;
7. Voluntarily surrender the machinery to PLGU-ILOILO when:
 - a. Not properly maintained and utilized for one year;

- b. Not settling the problems arising in the use for the period of one year;
 - c. There is written complaint and any sanctions arising from using, coming from the residents nearby and government/s units;
 - d. Not complying with the Memoranda of Agreement.
8. Strictly abide and follow the provisions, terms and conditions of the agreement as stipulated in MOA.

NOW, THEREFORE, on motion of HON. JOEL L. SAYSON, Chairman, Committee on Agriculture and Aquatic Resources and duly seconded by Hon. Pinky A. Jarina, Hon. Adrian S. Camposagrado, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,

RESOLVED, to authorize Atty. Virgilio T. Teruel, Municipal Mayor, to Enter Into A Memorandum of Agreement with the Provincial Local Government Unit of Iloilo as Recipient/Beneficiary of One (1) Unit Cultivator in Connection with the Implementation of the Agriculture and Fisheries Modernization Act (AFMA);

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, and all concerned for their information and/or appropriate action.
