RESOLUTION CONFORMING AND APPROVING THE CY 2026 ANNUAL BUDGET OF BARANGAY BINALIUAN MAYOR, TIGBAUAN, ILOILO

WHEREAS, on March 3, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2026 Annual Budget of Barangay Binaliuan Mayor, as duly approved by their Sangguniang Barangay, for review and appropriate legislative action;

WHEREAS, the Annual Budget of Barangay Binaliuan Mayor, as approved under Appropriation Ordinance No. 2026-01 dated January 14, 2026, amounts to Four Million Four Hundred Seventy Five Thousand Pesos (₱4,475,000.00), with the following budget components: 20% Development Fund (₱863,737.60), 10% Sangguniang Kabataan Fund (₱447,500.00), 5% Barangay Disaster Risk Reduction and Management Fund (₱223,750.00) and Gender and Development (GAD) Attribution (₱714,175.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Municipal Budget Officer, after review, found the said barangay budget to be compliant with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, under Section 333 of the Local Government Code of 1991, the Sangguniang Bayan shall review the barangay budgets to ensure that the same comply with prescribed requirements and limitations;

WHEREAS, it is the responsibility of the concerned barangay officials to ensure the lawful and proper implementation of the approved budgets in accordance with applicable laws and regulations;
