RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH 1LIFE, INC. PRIMARY CARE FACILITY (1 LIFE INC. PCF) IN CONNECTION WITH THE PROVISION OF LABORATORY SERVICES IN COLLABORATION WITH THE TIGBAUAN PRIMARY CARE FACILITY

WHEREAS, the Local Chief Executive in a letter dated March 13, 2026 requested this Sangguniang Bayan for an URGENT passing of a *“Resolution Granting Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan, to Enter Into A Memorandum of Agreement (MOA) With 1LIFE, INC. Primary Care Facility (1LIFE INC. PCF) in Connection With the Provision of Laboratory Services in Collaboration With the Tigbauan Primary Care Facility;”*

WHEREAS, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- **1LIFE INC. PRIMARY CARE FACILITY (1LIFE INC. PCF)**, a Department of Health-Licensed Primary Care and Clinical Laboratory Facility, represented by its authorized representative, **VANESSA T. SALINAS**, Iloilo Branch Manager, referred as **“1LIFE INC. PCF;”** and
- **The MUNICIPALITY OF TIGBAUAN**, Province of Iloilo, represented by its Municipal Mayor, **ATTY. VIRGILIO T. TERUEL**, referred as the **“REFERRING PARTY”**

WHEREAS, the REFERRING PARTY provides primary health services to its constituents through its health facilities;

WHEREAS, 1LIFE INC. PCF operates a clinical laboratory duly licensed and regulated by the Department of Health (DOH);

WHEREAS, the REFERRING PARTY desires to make available laboratory diagnostic services to its patients through the facilities and services of 1LIFE INC. PCF;

WHEREAS, the Parties agree to collaborate in facilitating specimen collection and laboratory testing in the Municipality of Tigbauan in accordance with applicable Department of Health regulations governing clinical laboratories;

WHEREAS, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. SERVICES

- 1.1 1LIFE INC. PCF shall make available the laboratory services to the REFERRING PARTY for diagnostic testing required by patients served by the REFERRING PARTY;
- 1.2 To facilitate such services, 1LIFE INC. PCF shall conduct offsite laboratory services in the Municipality of Tigbauan, during which its authorized and qualified personnel shall perform specimen collection and other necessary laboratory procedures within facilities designated by the REFERRING PARTY;
- 1.3 The facilities provided by the REFERRING PARTY shall serve as the designated venue for specimen collection, while laboratory testing may be conducted either onsite during laboratory runs or at the main laboratory of 1LIFE INC. PCF, as appropriate;
- 1.4 All specimen collection, handling, testing and reporting shall comply with applicable Department of Health regulations, standards and licensing requirements governing clinical laboratories.

2. RESPONSIBILITIES OF 1LIFE INC. PCF

1LIFE INC. PCF shall:

- 2.1 Deploy qualified and authorized laboratory personnel to conduct specimen collection and laboratory services in the Municipality of Tigbauan;
- 2.2 Ensure that all specimen collection procedures follow DOH-prescribed standards and laboratory protocols;
- 2.3 Provide the necessary equipment, supplies and materials required for specimen collection and laboratory testing;
- 2.4 Conduct laboratory testing and analysis in accordance with accepted clinical laboratory standards and DOH regulations;
- 2.5 Reserve the right to accept or reject specimens that do not meet laboratory standards, with proper notification to the REFERRING PARTY.

3. RESPONSIBILITIES OF THE REFERRING PARTY

The **REFERRING PARTY** shall:

- 3.1 Provide a suitable space or facility within the Municipality of Tigbauan where specimen collection activities may be conducted by 1LIFE INC. PCF personnel;
- 3.2 Assist in the coordination of patients and scheduling of offsite laboratory activities;
- 3.3 Ensure that patients are properly identified and prepared for laboratory testing.

4. RELEASE OF THE RESULTS

- 4.1 1LIFE INC. PCF shall release laboratory results to the authorized representatives of the REFERRING PARTY within the applicable turnaround time for the requested tests;
- 4.2 Results may be transmitted through secure electronic means or other authorized communication channels;
- 4.3 The REFERRING PARTY shall be responsible for communicating the laboratory results to the attending physician or patient.

5. CONFIDENTIALITY

Both parties shall maintain strict confidentiality of all patient records and laboratory results in accordance with the Data Privacy Act of 2012 and applicable health regulations.

6. NO AGENCY RELATIONSHIP

Nothing in this Agreement shall be construed as creating an employer-employee relationship, partnership or joint venture between the Parties.

Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

RESOLVED, to grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan, to Enter Into A Memorandum of Agreement (MOA) With 1LIFE INC. Primary Care Facility (1LIFE INC. PCF) in Connection With the Provision of Laboratory Services in Collaboration With the Tigbauan Primary Care Facility;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to 1LIFE INC. PCF represented by its Iloilo Branch Manager, Vanessa Salinas and other concerned for their information and/or appropriate action.
