RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL, TO SIGN A DEED OF DONATION EXECUTED BY THE PROVINCE OF ILOILO IN CONNECTION WITH THE ONE (1) UNIT CULTIVATOR

WHEREAS, in a letter dated March 23, 2026, the Local Chief Executive requested the Sangguniang Bayan for the urgent passage of a resolution authorizing the Municipal Mayor, Atty. Virgilio T. Teruel, to sign a Deed of Donation executed by the Province of Iloilo in connection with one (1) unit cultivator;

WHEREAS, the said Deed of Donation shall be entered into by and between:

- **The PROVINCE OF ILOILO**, a local government unit duly created and existing at Bonifacio Drive, Iloilo City, represented by its Governor, Hon. Arthur R. Defensor, Jr., hereinafter referred to as the **DONOR**; and
- **The MUNICIPALITY OF TIGBAUAN**, a local government unit duly created and existing under the laws of the Republic of the Philippines, with office address at Tejero St., Brgy. 9 Poblacion, Tigbauan, Iloilo, represented by its Municipal Mayor, Hon. Virgilio T. Teruel, hereinafter referred to as the **DONEE**;

WHEREAS, the DONOR is committed to providing assistance to its constituents through the provision of goods and services when funds are available;

WHEREAS, Section 16 of the Local Government Code provides that every local government unit shall exercise powers necessary and incidental for its efficient and effective governance and for the promotion of the general welfare;

WHEREAS, the Provincial Government of Iloilo has the authority, as provided by law, to acquire, develop, lease, encumber, alienate, or otherwise dispose of real and personal property and to utilize its resources for developmental and welfare purposes;

WHEREAS, donations from the Provincial Government will enable the DONEE to deliver services more effectively and efficiently, thereby improving the economic and social conditions of its constituents;

WHEREAS, Section 4(3) of Resolution No. 2023-02 authorizes the Governor to transfer assets and extend donations to local government units pursuant to Section 381 of the Local Government Code of 1991 and in compliance with COA Circular No. 2012-001;

WHEREAS, the DONOR, through the authority of the Sangguniang Panlalawigan, has expressed its intent to donate one (1) unit cultivator to the DONEE for official use in furtherance of its mandate and functions, subject to the following conditions:

- The DONEE shall record the donated item in its books of accounts and property records in accordance with Commission on Audit rules and regulations;
- The DONEE shall ensure that the donation shall be used solely for official purposes; and
- The DONEE shall assume responsibility for the maintenance and preservation of the donated equipment;

NOW, THEREFORE, on motion of HON. JOEL L. SAYSON, Chairman, Committee on Agriculture and Aquatic Resources, duly seconded by Hon. Pinkly A. Atadero-Jarina, Hon. Adrian S. Camposagrado, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor, Atty. Virgilio T. Teruel, to sign the Deed of Donation executed by the Province of Iloilo in connection with the one (1) unit cultivator;

RESOLVED FURTHER, that copies of this Resolution be furnished to Hon. Mayor Virgilio T. Teruel, Hon. Governor Arthur R. Defensor, Jr., and all concerned offices for their information and appropriate action.
