RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DR. VENUS T. TOLEDO RELATIVE TO THE REQUIREMENT OF PHILHEALTH CIRCULAR NO. 30, SERIES OF 2009 THAT ALL RURAL HEALTH UNITS SHALL HAVE PARTNER PHYSICIANS FOR EMERGENCY OBSTETRIC AND NEWBORN/PEDIATRIC CASES AS PREREQUISITE TO THEIR MATERNITY CARE PACKAGE ACCREDITATION.

WHEREAS, the Local Chief Executive in a letter dated March 23, 2026 requested this Sangguniang Bayan for an URGENT passing of a *“Resolution Authorizing Atty. Virgilio T. Teruel, Municipal Mayor, to Enter Into A Memorandum of Agreement With Dr. Venus T. Toledo Relative to the Requirement of PhilHealth Circular No. 30, Series of 2009 That All Rural Health Units Shall Have Partner Physicians for Emergency Obstetric and Newborn/Pediatric Cases as Prerequisite to Their Maternity Care Package Accreditation;”*

WHEREAS, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The **Local Government of the Municipality of Tigbauan**, a government office with office address at Tejero St., Tigbauan, Iloilo, represented by its Local Chief Executive, **ATTY. VIRGILIO T. TERUEL**, referred to as **FIRST PARTY**; and
- **DR. VENUS T. TOLEDO**, of legal age, Filipino and a resident of Barangay 1 Poblacion, Tigbauan, Iloilo. She practices as an Obstetrician-Gynecologist (OBGYN), referred to as **SECOND PARTY**.

WHEREAS, every Philippine Health Insurance Corporation (PhilHealth) accredited non-hospital facility providing Maternal Care Package is required to have partner physicians with Basic Emergency Obstetric and Newborn Care (BEmONC) training for patient referrals/backup; and

WHEREAS, the **FIRST PARTY** has requested the **SECOND PARTY** to be one of its referrals/back up physicians in relation to its Maternal Care Package service requirement;

WHEREAS, for and in consideration of the foregoing premises, the **PARTIES** have agreed to the following terms and conditions:

Obligations of the FIRST PARTY:

1. That the referred cases of the **FIRST PARTY** shall be sent to the **SECOND PARTY** as needed or unless requested by the client/patient;

2. That said referral shall be accompanied by a referral form properly filled up by the FIRST PARTY;
3. That the FIRST PARTY shall exert utmost effort to notify the SECOND PARTY;
4. That the FIRST PARTY shall assess and inform the client/patient that the partner Physician might be charging professional fee for the referral;
5. In cases of consultation and referrals, the FIRST PARTY shall determine the necessity of the referral; and
6. In case of emergency referrals, the FIRST PARTY shall refer client to the nearest hospital of choice of the client. If possible, notify the SECOND PARTY of the case and the foregoing referrals for his knowledge.

Obligation of the SECOND PARTY:

1. That for emergency cases referred, the SECOND PARTY shall provide services to the patient even after clinic hours;
2. That in case of admission to the hospital of the referred client/patient the SECOND PARTY shall inform the FIRST PARTY the status of the patient; and
3. The SECOND PARTY shall fill up the proper forms when referring back to the FIRST PARTY the patient concerned.

Common Provisions. The PARTIES agree that their attendance to the patients are independent of each other, hence, each PARTY is individually liable for any incident that may occur during the time that the patient is under his/her care.
