Resolution No. 2026-107

A RESOLUTION EXPRESSING THE INTENT OF THE SANGGUNIANG BAYAN OF TIGBAUAN TO REQUEST THE DEPLOYMENT OF A RURAL HEALTH PHYSICIAN (RHP) UNDER THE DOCTORS TO THE BARRIOS (DTTB) PROGRAM.

WHEREAS, the Municipality of Tigbauan is committed to ensuring the delivery of accessible, equitable, and quality healthcare services to all its constituents, particularly those in underserved and remote barangays;

WHEREAS, there is a need to strengthen the provision of primary healthcare services in the municipality due to the limited number of physicians serving the growing population;

WHEREAS, the Department of Health, through its Doctors to the Barrios (DTTB) Program, deploys competent and dedicated physicians to municipalities with inadequate medical personnel to address gaps in healthcare delivery;

WHEREAS, the presence of a Rural Health Physician (RHP) under the DTTB Program will significantly enhance the capability of the Rural Health Unit in delivering essential health services, including preventive, promotive, curative and rehabilitative care;

WHEREAS, the deployment of a DTTB physician will further strengthen the implementation of national health programs and support the realization of Universal Health Care in the municipality;

WHEREAS, pursuant to the guidelines of the DTTB Program, the Local Government Unit (LGU) shall undertake the following responsibilities:

- Provide modest board and lodging to the deployed Rural Health Physician;*
- Assign the RHP to a primary care facility owned and managed by the LGU;*
- Appropriate counterpart funding and extend necessary support, including but not limited to per diems, transportation, communication allowance, and other incidental expenses to enable the RHP to effectively perform his/her duties, including participation in learning and development activities;*
- Develop and enforce protocols to ensure the welfare, security, and occupational safety and health of the RHP, especially when assigned in Geographically Isolated and Disadvantaged Areas (GIDAs);*

- e. Support policies, programs, and initiatives introduced by the RHP in strengthening and improving the local health system, consistent with the implementation of the Universal Health Care Act; and
- f. Designate a Safety Officer and establish a Safety and Security Committee to ensure the protection and well-being of the augmented DTTBs, in accordance with Occupational Safety and Health (OSH) standards under CSC-DOH-DOLE Joint Memorandum Circular No. 1, s. 2020;

NOW, THEREFORE, on motion of Hon. PINKY A. JARINA, Chairperson, Committee on Health and Sanitation and duly seconded by Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,

BE IT RESOLVED, as it is hereby resolved, to express the intent of the Sangguniang Bayan of Tigbauan to formally request the deployment of a Rural Health Physician (RHP) under the Doctors to the Barrios (DTTB) Program of the Department of Health;

RESOLVED FURTHER, that the Local Government Unit of Tigbauan shall extend full support to the assigned physician, including but not limited to provision of necessary facilities, logistical assistance, and other forms of support to ensure the effective delivery of health services;

RESOLVED FINALLY, that copies of this Resolution be furnished to the Department of Health Regional Office VI, the Provincial Health Office of Iloilo, and other concerned offices for their information and appropriate action.
