RESOLUTION CONFORMING AND APPROVING THE CY 2026 ANNUAL BUDGET OF BARANGAY BUENAVISTA AND CY 2026 SUPPLEMENTAL BUDGET OF BARANGAY CORDOVA SUR, MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on March 9, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2026 Annual Budget of Barangay Buenavista, as duly approved by the Sangguniang Barangay, for review and appropriate legislative action;

WHEREAS, on March 16, 2026, the Municipal Budget Officer of Tigbauan, Iloilo likewise endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2026 Supplemental Budget of Barangay Cordova Sur, as duly approved by the Sangguniang Barangay, for review and appropriate legislative action;

WHEREAS, the Annual Budget of Barangay Buenavista, as approved under Appropriation Ordinance No. 2026-01 dated February 15, 2026, amounts to THREE MILLION FOUR HUNDRED THOUSAND PESOS (P3,400,000.00), with the following budget components: 20% *Development Fund* (P665,418.40), 10% *Sangguniang Kabataan Fund* (P340,000.00), 5% *Barangay Disaster Risk Reduction and Management Fund* (P170,000.00) and *Gender and Development (GAD) Attribution* (P526,151.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2026-01 embodied in Barangay Appropriation Ordinance No. 2026-02 of Barangay Cordova Sur in the amount of THREE HUNDRED EIGHTY FOUR THOUSAND PESOS (P384,000.00) is intended for the procurement of Barangay Patrol Vehicle, Additional CCTVs, Refrigerator, ICT Equipment and Fund for Land Survey and Katarungang Pambarangay Services, chargeable against the CY 2025 Quarry Share;

WHEREAS, the Municipal Budget Officer, after due review, found the said barangay annual and supplemental budgets to be compliant with the provisions of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the responsibility of the concerned barangay officials to ensure the lawful and proper implementation of the approved budgets in accordance with applicable laws and regulations;

NOW THEREFORE, on motion of HON. NORA ROSE T. TUBIANO, Chairperson, Committee on Appropriations, Budget, Finance & Accounts and Ways & Means, duly seconded by Hon. Pinky A. Jarina, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Tigbauan, to conform with and approve the CY 2026 Annual Budget of Barangay Buenavista and CY 2026 Supplemental Budget of Barangay Cordova Sur, this municipality;
