Resolution No. 2026-111

A RESOLUTION TEMPORARILY AMENDING RULE VII, SECTION 14(a) OF RESOLUTION NO. 2025-087, OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE (IRP) OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, BY TRANSFERRING THE REGULAR SESSION SCHEDULED ON APRIL 1, 2026 TO MARCH 30, 2026 AT 9:00 O'CLOCK IN THE MORNING

WHEREAS, Rule VII, Section 14(a) of the Internal Rules of Procedure provides:

"RULE VII – REGULAR AND SPECIAL SESSIONS

Section 14. REGULAR SESSION

(a) The regular session shall be held every Wednesday and shall start promptly at 9:00 o'clock in the morning; provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause, the next working day shall be the regular session day;"

WHEREAS, April 1, 2026 falls on a Wednesday, which is the regular session day of the Sangguniang Bayan;

WHEREAS, due to the long weekend (April 2 - Holy Thursday & April 3 – Good Friday) and the need to act on several urgent resolutions, the Sangguniang Bayan deems it necessary to transfer the regular session scheduled on April 1, 2026 to an earlier date;

NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Vice Chairman, Committee on Rules, Ordinances and Resolution (under the sponsorship of the Committee Chairman, Hon. Marlon R. Teruñez), and duly seconded by Hon. Pinky A. Jarina, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,

RESOLVED, to temporarily amend Rule VII, Section 14(a) of Resolution No. 2025-087, otherwise known as the Internal Rules of Procedure (IRP) of the Sangguniang Bayan of Tigbauan, Iloilo, by transferring the Regular Session scheduled on April 1, 2026 to March 30, 2026 at 9:00 o'clock in the morning,
