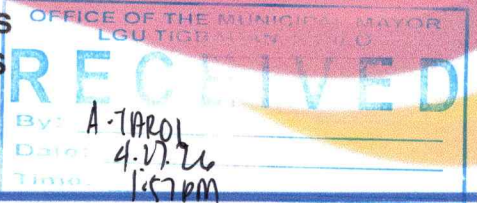

A RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO ENTER INTO A CONTRACT WITH MR. FELIX C. TABIO AS A VILLAGE-BASED ARTIFICIAL INSEMINATION TECHNICIAN (VBAT) IN CONNECTION WITH THE PROGRAMS AND ACTIVITIES OF THE PHILIPPINE CARABAO CENTER IN THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, in a letter dated April 20, 2026, the Local Chief Executive requested this Honorable Body for the urgent passage of this Resolution;

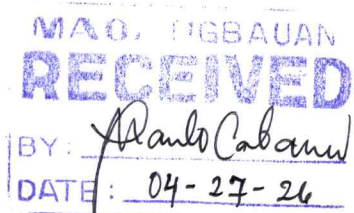

WHEREAS, the Village-Based Artificial Insemination Technician (VBAT) contract shall be entered into by and between the following parties:

- **The Municipality of Tigbauan**, with principal office at Poblacion, Tigbauan, Iloilo, represented herein by its Municipal Mayor, Atty. Virgilio T. Teruel, hereinafter referred to as the LGU; and
- **Mr. Felix C. Tabio**, with residence at Brgy. Namocon, Tigbauan, Iloilo, hereinafter referred to as the VBAT;

WHEREAS, the Philippine Carabao Center (PCC) was established by virtue of Republic Act No. 7307 to conserve, propagate, and promote the Philippine carabao as a source of draft power, milk, meat, and hide;

WHEREAS, the LGU and the PCC recognize the importance of cooperative efforts in pursuing development objectives pursuant to Republic Act No. 7307 and the Local Government Code of 1991;

WHEREAS, to accelerate the development and improvement of the Philippine carabao for meat and milk production, both parties have agreed to collaborate in promoting and undertaking programs related to the development of the carabao industry and in improving the standard of living in rural areas;



WHEREAS, both parties recognize that one of the most practical methods of accelerating the improvement of the Philippine carabao is through crossbreeding using artificial insemination conducted by trained village-based technicians;

NOW, THEREFORE, on motion HON. JOEL L. SAYSON, Chairman, Committee on Agriculture and Aquatic Resources, duly seconded by Hon. Pinky A. Jarina, Hon. Adrian S. Camposagrado, Hon. Marlon R. Teruñez, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton, be it:

RESOLVED, as it is hereby resolved, to authorize Atty. Virgilio T. Teruel, Municipal Mayor, to enter into a contract with Mr. Felix C. Tabio as a Village-Based Artificial Insemination Technician (VBAT) in connection with the programs and activities of the Philippine Carabao Center;

RESOLVED FURTHER, that the terms and conditions of the contract shall include, but not be limited to the following:

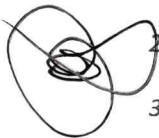
ARTICLE I – RESPONSIBILITIES OF THE LGU

The LGU shall:

- 
1. Recommend the nominated Village-Based Technician for AI training;
 2. Act as guarantor of the faithful performance of the VBAT through the execution of a contract;
 3. Supervise and provide assistance to the VBAT in implementing the genetic improvement program;
 4. Monitor the performance of the VBAT and collect reports for submission to the Provincial AI Coordinator;
 5. Promote the services of the VBAT in the community and empower them to become self-reliant, including participation in planning, monitoring, evaluation, and documentation of project activities.

ARTICLE II – RESPONSIBILITIES OF THE VBAT

The VBAT shall:

- 
1. Conduct pregnancy diagnosis, artificial insemination, and monitor animals inseminated, impregnated, and calves produced within the area of coverage;
 2. Prepare and submit reports to PCC/DA/LGU, including annual inventory of carabaos, number of animals inseminated, impregnated, calves produced, and frozen semen utilization;
 3. Properly maintain and handle frozen semen, AI tanks, and supplies, and immediately report any loss or damage to PCC and LGU;
 4. Pay, at cost, for liquid nitrogen, frozen semen, and other AI supplies obtained from PCC after two (2) years of receiving them free of charge;
 5. Reimburse training expenses incurred by PCC amounting to Thirty Thousand Pesos (₱30,000.00) in the event of failure to perform stipulated responsibilities within two (2) years;
 6. Voluntarily surrender loaned AI equipment to PCC upon termination of this contract or at the end of the project.

ARTICLE III – PERIOD OF AGREEMENT

This Agreement shall take effect upon signing by all parties and shall remain valid for a period of five (5) years, unless extended upon mutual agreement.

No party shall terminate their commitment within the five (5)-year period except for justifiable cause as may be provided under applicable laws and regulations.

ARTICLE IV – LIABILITY CLAUSE

The LGU shall not be held liable for any claims for losses, damages, injuries, harm, or death suffered by third parties or damage to property arising from or in connection with the activities of the VBAT, including those resulting from acts, omissions, or negligence of the VBAT.

RESOLVED FINALLY, that copies of this Resolution be furnished to the Office of the Municipal Mayor, the Philippine Carabao Center, and all concerned offices for their information and appropriate action.
