RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY BAGACAY ORDINANCE NUMBER 2026-001," AN ORDINANCE PRESCRIBING A FILING FEE FOR CASES BROUGHT BEFORE THE LUPONG TAGAPAMAYAPA (KATARUNGANG PAMBARANGAY) AND BARANGAY ORDINANCE NO. 2026-002 "AN ORDINANCE REGULATING THE OPERATION OF VIDEOKE MACHINES, KARAOKE SYSTEMS AND OTHER LOUD-SOUND-PRODUCING DEVICES WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY BAGACAY, TIGBAUAN ILOILO."

WHEREAS, as stated in the Local Government Code Section 447. Powers, Duties, Functions and Compensation. (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

- (1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:
- (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Sangguniang Barangay of Bagacay adopted and approved Ordinances No. 2026-001 and 2026-002 on April 1, 2026;

WHEREAS, Barangay Bagacay Ordinances No. 2026-001 and 2026-002 were endorsed to the Sangguniang Bayan of Tigbauan by Mr. Aurelio Ticorda MLGOO VI on April 14, 2026;

WHEREAS, on April 15, 2026, the said Barangay Ordinances were referred to the Committee on Rules, Ordinances, and Resolutions for review and recommendations;

WHEREAS, upon review, the committee has found that the said ordinances followed certain prerequisites in the formulation of ordinances and are consistent with the provisions of the Local Government Code, to wit;

SECTION 391. Powers, Duties, and Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as maybe necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;
- (14) Prescribe fines in amounts not exceeding One thousand pesos (P1,000.00) for violation of barangay ordinances;
- (15) Provide for the administrative needs of the lupong tagapamayapa and the pangkat ng tagapagkasundo;
- (24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.

NOW, THEREFORE, on motion of HON. MARLON R. TERUNEZ, Chairman, Committee on Rules, Ordinances, and Resolutions and duly seconded by Hon. Pinky A. Jarina, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,
