RESOLUTION AUTHORIZING MS. EDEN MAE G. ERTA, REVENUE COLLECTION OFFICER ASSIGNED IN THE MUNICIPALITY OF TIGBAUAN, AND MS. MARY GRACE M. TRIO, MUNICIPAL ACCOUNTANT, TO REPRESENT THE MUNICIPALITY OF TIGBAUAN BEFORE THE BUREAU OF INTERNAL REVENUE (BIR) FOR THE PURPOSE OF UPDATING ITS CERTIFICATE OF REGISTRATION (COR)

WHEREAS, in a letter dated April 27, 2026, the Local Chief Executive, Atty. Virgilio T. Teruel, respectfully requested the Sangguniang Bayan for the urgent passage of the aforementioned Resolution;

WHEREAS, the Certificate of Registration (COR) issued by the Bureau of Internal Revenue serves as proof of the Municipality's registration and compliance with tax regulations, as well as its legal authority to operate in the Philippines;

WHEREAS, the Local Government Unit of Tigbauan is a municipal corporation created by law and has corporate powers under Section 22 of the Local Government Code of 1991;

WHEREAS, there is a need to update the Municipality's Certificate of Registration with the Bureau of Internal Revenue;

WHEREAS, Ms. Eden Mae G. Ertas, Revenue Collection Officer assigned in this Municipality, and Mrs. Mary Grace M. Trio, Municipal Accountant, are hereby designated as representatives of the Office of the Municipal Accountant to update the Certificate of Registration (COR) of the Municipality;
