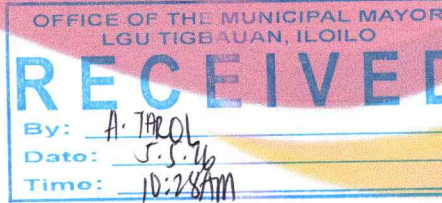

Resolution No. 2026-131

A RESOLUTION CONVERTING AND RECOGNIZING THE DAY CARE WORKERS OF THE MUNICIPALITY OF TIGBAUAN AS CHILD DEVELOPMENT WORKERS PURSUANT TO REPUBLIC ACT NO. 12199, OTHERWISE KNOWN AS THE "EARLY CHILDHOOD CARE AND DEVELOPMENT SYSTEM ACT"

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants local government units the authority to exercise powers essential to promote the general welfare of their constituents, including the welfare and development of children;

WHEREAS, Republic Act No. 6972 mandates the establishment of Day Care Centers in every barangay and recognizes the importance of community-based child care and development programs for children up to six (6) years of age;

WHEREAS, Republic Act No. 8980 institutionalized the Early Childhood Care and Development (ECCD) System and identified child care service providers as essential partners in the holistic growth and development of Filipino children;

WHEREAS, Republic Act No. 12199, enacted on May 8, 2025, further strengthened the ECCD System, repealed Republic Act No. 10410, and expressly professionalized and institutionalized the positions of Child Development Teachers and Child Development Workers, thereby recognizing them as frontline ECCD service providers in local government units;

WHEREAS, the transition from the designation of “Day Care Worker” to “Child Development Worker” reflects the expanded and professionalized role of these personnel in delivering holistic early childhood care, education, nutrition, and developmental services to children;

WHEREAS, the Municipality of Tigbauan recognizes the indispensable role of its Day Care Workers in implementing child-centered development programs and deems it necessary to align its local ECCD structure with the national legal framework;

NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, Committee on Social Justice, Welfare & Development (*Including Children, Family Affairs & Indigents*) and duly seconded by Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Lorna T. Domingo;

RESOLVED, as it is hereby resolved, to convert and officially recognize all existing Day Care Workers of the Municipality of Tigbauan as Child Development Workers (CDWs) in accordance with Republic Act No. 12199.

RESOLVED FURTHER, that the Municipal Government, through the Office of the Municipal Mayor, the Municipal Social Welfare and Development Office (MSWDO), shall provide continuing capability-building, training, and professional development opportunities for Child Development Workers to strengthen the delivery of ECCD services in the municipality.

RESOLVED FINALLY, that copies of this Resolution be furnished to the Office of the Municipal Mayor, and the Municipal Social Welfare and Development Office, for information and appropriate action.
