Resolution No. 2026-132

A RESOLUTION GRANTING AUTHORITY TO HON. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CARABAO CENTER (PCC) IN CONNECTION WITH THE BULL ENTRUSTMENT PROGRAM (BEP)

WHEREAS, this Memorandum of Agreement is to be entered into by and between the following parties:

- The **Philippine Carabao Center (PCC)**, a national government agency attached to the Department of Agriculture, with principal office at the Science City of Muñoz, Nueva Ecija, represented herein by Dr. Myrtel C. Alcazar, in his/her capacity as Center Director of PCC at West Visayas State University, with office at Brgy. Simsiman, Calinog, Iloilo, hereinafter referred to as the PCC; and
- The **Municipality of Tigbauan**, a local government unit with principal office at the Municipal Hall, Tigbauan, Iloilo, represented herein by Atty. Virgilio T. Teruel, Municipal Mayor, hereinafter referred to as the LGU;

WHEREAS, in a letter dated May 5, 2026, the Local Chief Executive requested this August Body, through Hon. Vice Mayor Lugen T. Ortilano, for the urgent passage of this Resolution;

WHEREAS, the PCC was established by virtue of Republic Act No. 7307, otherwise known as the "Philippine Carabao Act of 1992," mandated to conserve, propagate, and promote the Philippine carabao as a source of draft power, meat, milk, and hide;

WHEREAS, the PCC operates under the supervision of the Bureau of Animal Industry pursuant to Republic Act No. 12308, or the "Animal Industry Development and Competitiveness Act," which expanded its mandate to include research and development for other livestock;

WHEREAS, both the LGU and the PCC recognize the importance of collaborative efforts in pursuing carabao development objectives;

WHEREAS, both parties acknowledge that accelerating the development and genetic improvement of the Philippine carabao is vital to enhancing its productivity as a source of draft power, milk, meat, and hide;

WHEREAS, one of the most practical and efficient approaches to achieving this objective is through crossbreeding using selected breeder bulls under the Bull Entrustment Program (BEP);

WHEREAS, both parties have the capability to identify qualified beneficiaries under the BEP, particularly those in areas with at least twenty-five (25) heads of female buffaloes;

WHEREAS, for and in consideration of the foregoing premises and mutual undertakings, the parties agree to implement the project under the following terms and conditions:

ARTICLE I. OBLIGATIONS OF THE PCC

1. The PCC shall provide Murrah buffalo bull(s) to qualified agri-based cooperatives, farmer groups, and individual farmer-applicants through the LGU for natural breeding purposes under the BEP;
2. The PCC shall transfer accountability for the bull(s) to the LGU through an Invoice-Receipt for Property;
3. The PCC shall extend technical assistance in areas such as general management of the bull(s), record-keeping, and related concerns, in coordination with the LGU; and
4. The PCC shall review, verify, and validate reports submitted by the LGU regarding the number of calves sired by the bull(s), as basis for approving the LGU's recommendation to transfer ownership to the bull handler and for the subsequent issuance of a Certificate of Ownership.

ARTICLE II. OBLIGATIONS OF THE LGU

1. The LGU shall supervise the effective implementation of the BEP within its jurisdiction;
2. The LGU shall identify beneficiaries and/or endorse applicants for the BEP, subject to PCC verification, validation, and approval;
3. The LGU shall assist the PCC in identifying and orienting farmer-cooperatives/beneficiaries on program guidelines and promote carabao dairying in the locality;
4. The LGU shall execute BEP contracts with each identified beneficiary, using the form prescribed by the PCC;
5. The LGU shall furnish the PCC with copies of the executed BEP contracts;
6. The LGU shall provide and shoulder transportation for the delivery of the entrusted bull(s) from the PCC to the designated location;
7. The LGU shall provide technical assistance on animal health services for the bull(s) and other livestock involved, in coordination with the PCC;
8. The LGU shall assign a livestock technician to monitor breeding performance, maintain records, and submit monthly reports to the PCC detailing breeding activities and outcomes;
9. The LGU shall insure the bull(s) with any member of the Livestock Insurance Pool or other qualified insurance providers; and
10. The LGU shall transfer ownership of the bull(s) to the beneficiary upon compliance with the required number of calves produced and subject to PCC approval.

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, Vice Chairman, Committee on Agriculture and Aquatic Resources, duly seconded by Hon. Pinky A. Jarina, Hon. Adrian S. Camposagrado, Hon. Marlon R. Teruñez, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo and Hon. Lorna T. Domingo,

BE IT RESOLVED, as it is hereby resolved, to grant authority to Atty. Virgilio T. Teruel, Municipal Mayor, to enter into the aforesaid Memorandum of Agreement with the Philippine Carabao Center;

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor Virgilio T. Teruel, Dr. Myrtel C. Alcazar, and all concerned offices for their information and appropriate action.
