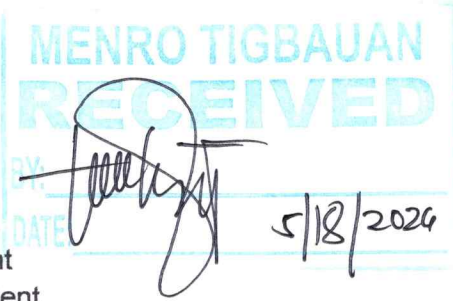

Resolution No. 2026-134

RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FOR THE CONSTRUCTION OF A MULTIPURPOSE BUILDING AND PURCHASE OF A GARBAGE COMPACTOR

WHEREAS, said Memorandum of Agreement shall be made and entered into by, and between the following parties:

- The ILOILO PROVINCIAL GOVERNMENT, a local government unit with principal address at Provincial Capitol Bldg., Bonifacio Drive, Iloilo City represented by the Hon. Governor, HON. ARTHUR R. DEFENSOR, JR., referred to as FIRST PARTY; and
- The MUNICIPALITY OF TIGBAUAN a local government unit with principal address at the Municipal Hall Bldg., Tejero Street, Tigbauan, Iloilo duly represented by its Mayor, HON. VIRGILIO T. TERUEL, herein referred to as SECOND PARTY;

WHEREAS, Republic Act No 9003 (R.A. 9003) otherwise known as the “Ecological Solid Waste Management act of 2000” was passed into a law on January 26, 2001 and mandates local government units to implement the same;

WHEREAS, the Province of Iloilo, in compliance with RA 9003 has adopted the “Ecological Solid Waste Management Program” to promote proper solid waste management in the whole Province and ultimately help in eradicating problems caused by garbage;

WHEREAS, the DENR issued Administrative Order No. 2001-34 (Implementing Rules and Regulations of RA 9003) and Administrative Order No. 2006-10 to set the Guidelines on Closure and Rehabilitation of Disposal Facility and Guidelines on Categorized Sanitary Landfill respectively;

WHEREAS, the Province of Iloilo has strategized the clustering of municipalities for use of common Sanitary Landfill as an immediate solution for the need of municipal LGUs for a final disposal facility and to be compliant with the requirement of law;

WHEREAS, the Iloilo Provincial Government provide financial assistance for the Solid Waste Management Support Facilities, Technologies, and/or Equipment for various municipalities;

WHEREAS, the **FIRST PARTY** has appropriated an amount of **Ten Million Pesos (P10,000,000.00)** in accordance with CY 2026 Annual Budget for the construction of Multipurpose Building and purchase of Garbage Compactor, chargeable against Subsidy-Others (Solid Waste Management Program) CY 2026 Budget, Office of the Governor (Supplemental Budget);

WHEREAS, the **SECOND PARTY** requested for the release of the above-mentioned amount to implement the program/project;

WHEREAS, the amount of P10,000,000.00 shall be transferred to the **SECOND PARTY** for the purpose thereof;

WHEREAS, premises considered, the **FIRST PARTY AND SECOND PARTY** hereby agree to the following:

1. The **FIRST PARTY** shall require the **SECOND PARTY** the submission of fund utilization on the said program/project upon its completion and submission of report of disbursement of the said fund;
2. The **SECOND PARTY** shall issue official receipt evidencing the receipt of the amount;
3. The **SECOND PARTY** shall submit Resolution of the Sanggunian authorizing the Municipal Mayor to sign the Memorandum of Agreement (MOA) with attached budgetary requirement/estimate as may be appropriated;
4. The **SECOND PARTY** shall purchase the above-mentioned equipment as specifically requested within six (6) months from the release of fund;
5. The **SECOND PARTY** shall implement the above-said project within three (3) months and liquidate the same within two (2) years from the release of funds;
6. In no case shall the **SECOND PARTY** re-transfer the herein amount to the other government agencies and/or local government units;
7. The **SECOND PARTY** shall return the excess or unused amount for the project to the **FIRST PARTY**, if any;
8. That, in case of any changes in the approved program of works, project proposal or breakdown of expenses, the **FIRST PARTY** must approve the same, otherwise the liquidation shall not be accepted and the amount granted as financial assistance shall be refunded;
9. The **SECOND PARTY** shall be responsible for the repair and maintenance of the above-mentioned facility/equipment/machinery/supplies funded by the **FIRST PARTY**;
10. The **SECOND PARTY** shall strictly comply with the applicable Commission on Audit rules and regulations in the purchase or acquisition of the above-cited equipment.

NOW THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, Committee on Environmental Protection, Disaster Resilience, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Pinky A. Jarina, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

RESOLVED, to grant authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality Of Tigbauan, to enter into a Memorandum Of Agreement (MOA) with the Iloilo Provincial Government for financial assistance in the Amount Of Ten Million Pesos

(P10,000,000.00) for the Construction of a Multipurpose Building and Purchase of a Garbage Compactor.

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to the Office of the Iloilo Provincial Government and to all concerned for their information and/or appropriate action.
