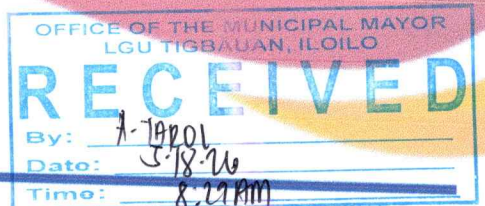

**Resolution No. 2026-135**

RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF ILOILO IN CONNECTION WITH THE IMPLEMENTATION OF THE ENHANCEMENT OF SHELLFISH INDUSTRY PROJECT

WHEREAS, a Memorandum of Agreement is to be entered into by and between the following parties:

- The **PROVINCIAL GOVERNMENT OF ILOILO**, a local government unit created under the laws of the Republic of the Philippines, represented by Honorable Governor **Arthur R. Defensor Jr.**, with postal address at Provincial Capitol Building, Bonifacio Drive, Iloilo City, herein referred to as the "PROVINCE"; and
- The **MUNICIPALITY OF TIGBAUAN**, a local government unit duly created under the laws of the Republic of the Philippines, represented by Honorable Mayor **Atty. Virgilio T. Teruel**, with postal address at Poblacion, Tigbauan, Iloilo, herein referred to as the "BENEFICIARY";

WHEREAS, in a letter dated May 11, 2026, the Local Chief Executive requested this August Body for the urgent passage of the aforementioned Resolution;

WHEREAS, the Philippine Constitution directs the State to protect the rights of subsistence fishermen, especially local communities, to the preferential use of communal marine and fishery resources, both inland and offshore, and to provide support through appropriate technology and research, adequate financial production and marketing assistance, and other services;

WHEREAS, Republic Act No. 8435, otherwise known as the **Agriculture and Fisheries Modernization Act (AFMA)**, envisions the strengthening of the agriculture and fisheries sector through modernization to attain food security, poverty alleviation, income enhancement and profitability, global competitiveness, and sustainability;



WHEREAS, the Province of Iloilo is mandated to promote agricultural development through a community-based farming systems approach emphasizing social justice, equity, productivity, and sustainability in the use of agricultural resources, and is providing agricultural extension and on-site research services and facilities to ensure that maximum assistance and access to resources in the production, processing, and marketing of agricultural and aqua-cultural products are extended to farmers, fishermen, and local entrepreneurs;

WHEREAS, the Provincial Agriculture Office supports the strategic goals on food security of the Province of Iloilo through the implementation of the **Enhancement of Shellfish Industry Project** for the agriculture and fisheries sector as indicated in the approved Annual Investment Program (AIP) for CY 2026;

WHEREAS, Republic Act No. 7160, otherwise known as the **Local Government Code of 1991**, mandates Municipal Local Government Units (MLGUs) to provide extension services and facilities related to agriculture and fishery activities to their constituents;

WHEREAS, the parties herein willingly and jointly agree to extend full support and cooperation for the effective implementation, operation, and good governance of the above-mentioned project;

WHEREFORE, for and in consideration of the foregoing premises and of the mutual covenants hereinafter set forth, the parties agree to enter into a Memorandum of Agreement subject to the following terms and conditions:

#### **ROLES AND RESPONSIBILITIES OF THE PARTIES**

##### **1. The Province of Iloilo shall:**

- a. Allocate funds for the implementation of the **Enhancement of Shellfish Industry Project**;
- b. Initiate and facilitate consultative and coordination meetings with partner stakeholders;
- c. Provide materials and technical assistance for the implementation of the project;
- d. Conduct regular data gathering, monitoring, and evaluation of the project; and
- e. Prepare the Project Terminal Report.

##### **2. The MLGU – Tigbauan shall:**

- a. Identify and endorse the project site for validation by the PLGU;
- b. Provide assistance in the project implementation through:
  - Construction of structures;
  - Conduct of regular monitoring and sampling;
  - Assignment of personnel-in-charge to facilitate activities and ensure that structures are maintained and secured;
  - Coordination and consultative meetings;
  - Ensuring project sustainability through continuous management of the project; and
  - Other necessary provisions that may arise during project implementation.

NOW, THEREFORE, on motion of HON. JOEL L. SAYSON, Chairman, Committee on Agriculture and Aquatic Resources, duly seconded by Hon. Pinkly Jarina, Hon. Adrian S. Camposagrado, Hon. Marlon R. Teruñez, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

RESOLVED, as it is hereby resolved, to grant authority to Hon. Mayor Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement (MOA) with the Provincial Government of Iloilo in connection with the implementation of the Enhancement of Shellfish Industry Project;

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor, Atty. Virgilio T. Teruel and all concerned offices for their information and appropriate action.
