A RESOLUTION ADOPTING THE LOCAL NUTRITION ACTION PLAN (LNAP) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO FOR CALENDAR YEARS 2026-2028.

WHEREAS, Section 16 of the Local Government Code of 1991 provides that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and for the promotion of the general welfare of its inhabitants;

WHEREAS, the State recognizes the importance of proper nutrition in nation-building and promotes the right of every Filipino to health and balanced nutrition, especially among infants, children, pregnant women, and other vulnerable sectors of society;

WHEREAS, the National Nutrition Council encourages all Local Government Units to formulate and implement their respective Local Nutrition Action Plans to address malnutrition and improve the nutritional status of their constituents;

WHEREAS, the Municipal Nutrition Committee of the Municipality of Tigbauan has formulated the Local Nutrition Action Plan (LNAP) for Calendar Years 2026-2028, which contains the priority programs, projects, and activities geared toward improving nutrition outcomes and promoting health and wellness in the municipality;

WHEREAS, the Local Nutrition Action Plan serves as a strategic framework to strengthen nutrition governance, intensify nutrition-specific and nutrition-sensitive interventions, and ensure the efficient implementation of nutrition programs at the municipal and barangay levels;

WHEREAS, the adoption of the said plan demonstrates the commitment of the Local Government Unit of Tigbauan to address malnutrition and support sustainable community development through collaborative and responsive nutrition initiatives;
