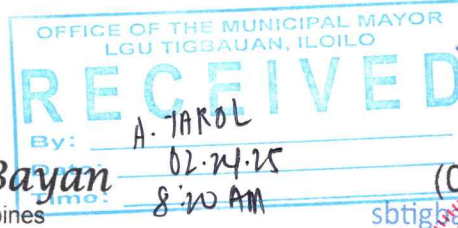

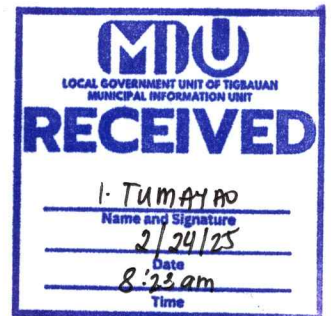

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF ALLERA STREET TO FOUR-WHEELED VEHICLES FROM MONDAY TO SATURDAY UNTIL THE REHABILITATION OF THE MAIN FOOD COURT INSIDE THE PUBLIC MARKET IS COMPLETED

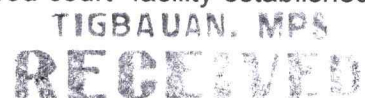
WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a) and (c), to wit:

“Closure of Roads – (a) A Local Government Unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebration, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: xxx”

WHEREAS, in a letter dated February 18, 2025, Atty. Virgilio T. Teruel, Municipal Mayor, requested this Sangguniang Bayan thru: Hon. Lugen T. Ortillano, Municipal Vice Mayor for the URGENT passing of the aforementioned Ordinance;

WHEREAS, this closure of road for four-wheeled vehicles is necessary in order to ensure the safety and efficient operation of a temporary food court facility established in Allera St., Tigbauan, Iloilo;

WHEREAS, there are thirteen (13) stall owners who are affected of the rehabilitation of the main food court inside the public market;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan that:

Section 1. COVERAGE – In connection with the rehabilitation of the main food court inside the public market of this municipality, the portion of Allera St. shall be temporarily closed to four-wheeled vehicles.

Section 2 – DURATION - The temporary closure shall take effect upon approval of this ordinance from Monday to Saturday until the rehabilitation of the main food court inside the public market is completed.

Section 3 – MISCELLANEOUS PROVISIONS – The Punong Barangay of Pob 9, of this municipality, with the aid of their Barangay Tanods shall facilitate the implementation of this ordinance and shall maintain safety health protocols, peace and order of the areas for the entire duration of the temporary closure.

Section 4. SEPARABILITY CLAUSE – If any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

Section 5 – EFFECTIVITY – This ordinance shall take effect upon approval of this ordinance.
