AN ORDINANCE FOR THE TEMPORARY CLOSURE OF PORTIONS OF ALLERA AND TEJERO STREETS IN THE MUNICIPALITY OF TIGBAUAN IN CONNECTION WITH THE OBSERVANCE OF THE LENTEN SEASON

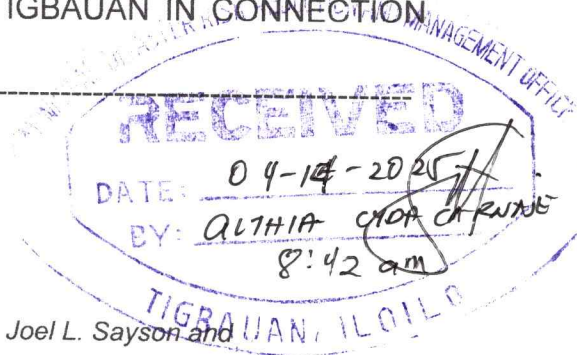
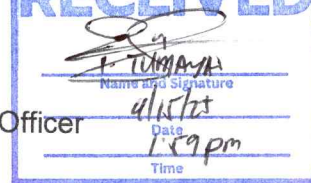
WHEREAS, the Local Government Code of 1991 provides, among others, under Section 21 (a), and (c), to wit:

"Closure of Roads – (a) A Local Government Unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction xxx;

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebration, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order xxx."

WHEREAS, Palm Sunday and Good Friday processions and other Lenten traditions are being observed by the Catholic Church and Catholic devotees during the celebration of the Holy Week;

WHEREAS, in order to allow smooth movement of the parishioners and devotees during these processions, the LGU has identified certain portions of Allera and Tejero Streets within the Poblacion (where crowds are expected to swarm) to be temporarily closed;



NOW, THEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan that:

SECTION 1. COVERAGE – In connection with the above-mentioned purpose, portions of Allera and Tejero Streets within the Poblacion in this municipality, shall be temporarily closed to motor vehicles.

SECTION 2. DURATION – The Temporary closure shall take effect, upon approval of this ordinance on the specific dates (as hereunder provided) in connection with the observance of the Lenten Season to wit:

1. For Palm Sunday - portion of Allera Street (in front of the St. John de Sahagun Parish Church) on April 13, 2025, from 12:01 A.M. to 9:00 A.M.
2. For Maundy Thursday, Good Friday, Black Saturday & Easter Sunday - portion of Allera Street (in front of the St. John de Sahagun Parish Church) & Tigbauan Municipal Grounds on April 17-20, 2025, from 12:01 A.M. to 10:00 A.M. and
3. For Good Friday *procession* - portion of Tejero Street (at the back of the Municipal Building until TCES) and RC Drive on April 18, 2025, from 12:00 P.M. until 10:00 P.M.

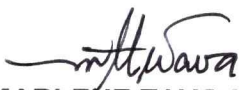
SECTION 3. MISCELLANEOUS PROVISIONS – The Punong Barangays of Barangay 8, 9 and Tan Pael, Tigbauan, Iloilo with the aid of their Barangay Tanods and the Tigbauan PNP shall facilitate the implementation of this ordinance and shall maintain safety health protocols, peace and order of the area for the entire duration of this temporary closure.

SECTION 4. SEPARABILITY CLAUSE – if any provision of this ordinance shall be declared null and void, unconstitutional or in conflict with the existing laws, ordinances and decrees, other parts not affected thereby shall remain valid and enforceable.

SECTION 5. EFFECTIVITY – This Ordinance shall take effect on April 13, and April 17-20, 2025.
