Municipal Ordinance No. 2025-010

AN ORDINANCE DECLARING AUGUST 31 OF EVERY YEAR AS A DAY OF OBSERVANCE OF THE “MAYOR EUGENIO T. TORRENTO DAY” IN THE MUNICIPALITY OF TIGBAUAN

Section 1. TITLE. This Ordinance shall be known as the “Mayor Eugenio T. Torrento Ordinance of Tigbauan.”

Section 2. DECLARATION OF AUGUST 31 AS “MAYOR EUGENIO T. TORRENTO DAY”. Through this ordinance, August 31 of every year is hereby declared as “Mayor Eugenio T. Torrento Day” in the Municipality of Tigbauan.

Section 3. DAY OF OBSERVANCE STATUS. Mayor Eugenio T. Torrento Day in the Municipality of Tigbauan, Iloilo shall be commemorated as a Day of Observance in recognition of the life, service, and legacy of Mayor Eugenio T. Torrento.

Section 4. COMMEMORATIVE ACTIVITIES. On this day, concerned agencies, schools, civic and private organizations, may conduct appropriate commemorative activities, ceremonies, and programs to honor his contributions to the municipality.

Section 5. PROTECTION AND CONSERVATION OF THE “MAYOR EUGENIO T. TORRENTO MEMORIAL MARKER.” The “Mayor Eugenio T. Torrento Memorial Marker,” located at Mayor Eugenio Torrento Elementary School, Barangay Parara Sur, Tigbauan, Iloilo, is hereby

declared a local cultural property of the Municipality of Tigbauan, and shall be included in the list of Tangible Cultural Properties stated in Municipal Ordinance No. 2023-013 entitled: "AN ORDINANCE PROVIDING FOR THE PROTECTION AND CONSERVATION OF LOCAL CULTURAL PROPERTIES, HISTORICAL MARKERS, MONUMENTS AND SHRINES AS PART OF THE STRENGTHENING AND IMPLEMENTING PROVISIONS OF THE NATIONAL CULTURAL HERITAGE ACT OF 2009", upon validation.

- 5.1. Its protection, conservation, and maintenance as a lasting heritage monument shall be ensured;
- 5.2. Any act of vandalism, destruction, or defacement against the Memorial Marker shall be strictly prohibited and subject to penalties under existing laws and municipal ordinances; and
- 5.3 The Local Government Unit of Tigbauan, through the Municipal Tourism, Heritage, Culture, and Arts Office, in coordination with the Department of Education and the Barangay Council of Parara Sur shall oversee the preservation and promotion of the said landmark.

Section 6. APPROPRIATION. The necessary funds for the observance of this day and the maintenance of the Mayor Eugenio T. Torrento Memorial Marker shall be included in the Annual Budget of the Municipality of Tigbauan, subject to the usual accounting and auditing rules and regulations.

Section 7. SEPARABILITY CLAUSE. The provisions of this Ordinance are separable, and in the event that any or more of such provisions are declared invalid, the validity of all other provisions shall not be affected hereby.

Section 8. REPEALING CLAUSE. Any Ordinance, Executive Orders and Local Issuance or Rules and Regulations or part thereof, inconsistent with or in conflict with this Ordinance are hereby repealed and or altered accordingly.

Section 9. EFFECTIVITY. This ordinance shall take effect immediately upon its approval, compliance to the requirements of the Local Government Code, and after posting in all affected historical monuments, markers, and shrines in a period of Two (2) consecutive weeks.
